Christmas Basket Program, Warming Center

Applications for the annual Chowchilla Christmas Bas**ket Program** will be taken on Saturday, December 1, 2012 from 9-11 a.m. at Life Change Church. You must provide a photo ID or driver's license and one public assistance document or utility bill showing current address. Applicants must qualify for the assistance program.

For those wishing to donate to the Community Christmas Basket Program: coats and cash donations are now

being accepted. Clean coats, gloves or scarves must be dropped off by December 6th to one of the following locations: Chamber of Commerce office. Paw Spa, SA Jones Land Co., or the Civic Center. Cash donations are being accepted at Tri-Counties Bank or at Grace Community Church.

The City of Chowchilla will take proactive measures to set up a "Warming Center" as needed for those residents not able to find a

warm location when extreme temperatures occur this winter. The Chowchilla Senior Center, located at 820 W. Robertson Boulevard, is open weekdays from 9:00 a.m. to 1:00 p.m. for those in need of warming and will be opened on an "as need" basis after 1:00 p.m. to accommodate those in need. GARBAGE PICKUP:

Garbage collection for Christmas Eve Day, Monday, 12/24 will remain the same. All service from Christmas Day, 12/25 - Friday, 12/28 will be delayed by one day. Collection on New Years Day (& following days) will be delayed 1 day.

TREE ROUNDUP:

The annual Christmas Tree Roundup will take place from January 7-11, 2013. Trees will be picked up free from your curbside. Please make sure all trees are free of decorations and any tree over six feet tall must be cut in half.

LEAF CLEANUP:

Autumn leaves may be falling but they should NOT be raked into piles and left in the street. All leaves should be placed in your GREEN waste container and put out for pick up service on your regularly scheduled garbage day.

Ask the City: Council Agendas

Ask the City is a feature column answering questions submitted to us by email, mail or phone.

How can I address City Council regarding an item not on the Council agenda?

B.C., Chowchilla

There is a brief time frame at the beginning of each regular City Council meeting where

the public is invited to address Council regarding any items not on the agenda. Speakers are limited to 3-5 minutes each and Council is prohibited by law from taking any action on matters discussed that are not on the agenda. No adverse conclusions should be drawn if Council does not respond to public comment at that time.

To get an item on an upcoming agenda, the City Clerk's office must be contacted within twenty days of the meeting date. For more information, call the City Clerk's office at 665-8615, ext. 102.

By the Fireside **CHECK BEFORE YOU BURN**

Check Before You Burn is the San Joaquin Valley Air Control District's annual residential fireplace-use regulation program which runs from Nov. - Feb. each winter. CBYB determines when residential wood burning will add dangerous levels of particulate matter - tiny pieces of soot, ash, dust and other materials - to the Valley's air, and prohibits the use of residential wood-burning devices.

High levels of particulate pollution can have serious health effects, including bronchitis, lung disease and increased risk of heart attacks and stroke. Young children,

elderly people and people with existing respiratory & coronary disease are especially vulnerable.

There are two forecast levels: "Wood burning Prohibited" and "Please Burn Cleanly." When a prohibition is declared, burning any solid fuel in a residential fireplace or wood-burning device is not permitted and violations may result in fines. Backyard chimneys and fire pits are also subject to the prohibitions. There are two exemptions - If the residence does not have access to naturalgas service, even if propane is available, or if burning solid

fuel is the sole source of heat for the residence.

Daily wood-burning forecasts will be available by county each day at 4:30 p.m. at www.valleyair.org/aginfo/ WoodBurnpage.htm, or by calling 800-766-4463.

Incentive discounts to upgrade your open fireplace or wood stove to a cleaner burning unit are now available through the Air District's "Burn Cleaner" program. For information, go to www.valleyair.org and click on the Grants & Incentives tab for an application or for a list of participating retailers.
