SERVING ON **COMMISSIONS** AND **COMMITTEES**

Boards and Commissions are integral to the foundation of our community that assist the City Council in making critical policy decisions that impact the community. These groups research, study and discuss specific issues with both short and long-term implications. Their recommendations are then forwarded to the Council for their consideration and action.

Citizen input is essential to the success of local government. The discussions and recommendations from Boards and Commissions is essential to maintaining quality services to the Chowchilla community.

These are voluntary positions and to be eligible a citizen must reside in the city limits of Chowchilla and be a registered voter. The terms of office are four years and members may serve consecutive terms.

HOW TO APPLY

Applications can be obtained at the Chowchilla City Hall, 130 S. Second St., online at www.CityOfChowchilla.org, or by calling the City Clerk's office at (559) 665-8615 ext. 102.

Applications are accepted on a continual basis and vacancies are filled as they become available. Following your submittal you will be notified if you qualify and when vacancies will occur on the Commission or Committee you are interested in.

Vacancies may include positions held by people who wish to serve another term. When that happens, qualified applicants may be selected as alternate members and then appointed to the Commission or Committee as full members in the event there is a resignation during the year.

APPLICATION DEADLINE

Applications are accepted continually. Vacancies are filled when a four-year appointment ends, or when an opening occurs due to a member's inability to complete their full term of appointment. Contact the City Clerk's office for information on the recruiting cycle.

AIRPORT ADVISORY COMMITTEE

Seven members act in an advisory capacity in all matters pertaining to administration, operation, development, improvement and maintenance of the municipal airport, except for leasing matters.

Meets quarterly and as needed in the Chowchilla City Hall Council Chambers.

HERITAGE PRESERVATION COMMISSION

Seven members act in an advisory capacity for the recognition, protection and promotion of the retention, revitalization and use of heritage resources in the City.

Meets quarterly and as needed in the Chowchilla City Hall Council Chambers.

PLANNING COMMISSION

Seven members act in an advisory capacity on proposed changes to the City General Plan for the physical development of the City, make recommendations on proposed zoning and land use, and exercise control over land subdivisions.

Meets at 7:00 p.m. every third Wednesday of the month and as needed in the Chowchilla City Hall Council Chambers.
